- <u>Lynda.com access and Flipped Workshops- Spring 2015</u> Access to Lynda.com is now available to all employees in the district. Rania is talking with DCS to provide flipped workshops using Lynda.com training videos beginning in Spring 2015. Training topics are software and soft skills.
- Upcoming Events -
 - Adjunct Orientation- Wednesday, Jan. 7, 2015: Professional Development to assist in planning for adjunct orientation as was done in the past several years back. Rania circulated a handout of proposed schedule and breakout sessions to the committee for review and feedback. The goal is to move away from orientation going for a long-period, sometimes till 10 p.m. or longer. Faculty committee members suggested doing a survey of adjunct faculty on the breakout session topics they would like for the next orientation sessions.
