GUIDELINES for considering and approving conference requests submitted to the Professional Development Committee:

The Professional Development Committee has approved funding for conferences and seminars **up to \$750 per year per full-time employee** for professional development for the 2020-2021 academic year.

A maximum of \$1,000 will be available per conference or workshop for up to two (2) or more people applying for the same event. Funding is available on a first-come, first serve basis.

Adjunct employees may be funded for up to a maximum of \$500 per year for professional development during COVID-19 remote working from home.**

Presenters are entitled to additional funding up to \$200.

Any employee who receives funding may be requested to share gained information with the campus community.

This is a series put together by USC, 12 sessions, equity recordings. Ernest Guillen noted that only a select few knew of this taking place on campus, and possibly through the Arts, Lecture & Diversity Committee, we could continue by storing the recordings to have open forums, can we keep

in the library, to include other stakeholders, e.g., students. Rania noted this was costly to participate for 5-7 people, and this was more employee centered, not sure about students. Those who attended the recordings could suggest how to disseminate. We would like to see how SBVC can get some traction.

Sabbatical Leave: Sabbatical leave was on the board agenda item recently. Raniah to check with the president's office and ask to make a campus-wide announcement. This application period is for 2022-2023 academic year.

Committee Reports: The committee members reported out on what is going on their specific areas, e.g., DSPS; Puente Program; Science and equity issues on campus; communication studies hiring more faculty and annual tournament on 11/18/21; book discussions are back; new department chair in Math.

Other: Rania mentioned a session with faculty on humanizing in the classroom. Rania will put something together, structured, research-based that provides autonomy.
